EXECUTIVE ORDER NO. 21 S. 2017

**AMENDING SECTION 1 OF THE EXECUTIVE ORDER NO. 02 S.2017 RECONSTITUTING
THE SOLID WASTE MANAGEMENT BOARD OF THE MUNICIPALITY OF BALIWAG,
INCLUDING ROMMEL BENIG OF GREEN ANTZ BUILDERS AND ERNESTO
RESURRECION OF CHANGE POLITICS MOVEMENT AS MEMBERS**

WHEREAS, the Solid Waste Management Board was created to Develop a long-term Solid Waste Management (SWM) Plan in which the various plans and strategies of the barangays of the municipality are integrated;


