EXECUTIVE ORDER NO. 21

**RECONSTITUTING THE MUNICIPAL HEALTH BOARD OF THE MUNICIPALITY OF
BALIWAG, BULACAN**

WHEREAS, Section 102 of Republic Act 7160, mandates that there shall be established in the municipality, a municipal health board.

NOW, THEREFORE, I, FERDINAND V. ESTRELLA, Municipal Mayor, Municipality of Baliwag, Bulacan, by virtue of the powers vested in me by law, do hereby order:

The composition of the local health boards shall be as follows:

Section 1. There is hereby established in the Municipality of Baliwag, Bulacan, a Municipal Health Board (MHB), pursuant to Section 102 Republic Act 7160, otherwise known as the Local Government Code of 1991. The composition of the MHB shall be:

- (a) Municipal Mayor, Chair;
- (b) Municipal Health Officer as Vice chair;
- (c) Chair, Committee on Health of the *Sangguniang Bayan*, member;
- (d) A representative of the Department of Health in the Municipality of Baliwag, member;
- (e) A representative from the private sector or non-governmental organizations involved in health services, member;

Section 2. Functions of the Municipal Health Board. - The Municipal Health Board shall:

- (1) To propose to the *Sanggunian Bayan*, in accordance with standards and criteria set by the Department of Health, annual budgetary allocations for the operation and maintenance of health facilities and services within the municipality.
- (2) To serve as an advisory committee to the *Sanggunian Bayan* on health matters such as, but not limited to, the necessity for, and application of, local appropriations for public health purposes; and
- (3) Consistent with the technical and administrative standards of the Department of Health, create committees which shall advise local agencies on matters such as, but not limited to, personnel selection and promotion, bids and awards, grievances and complaints, personnel discipline, budget review, operations review and similar functions.

Section 3. Meetings and Quorum;

- (a) The MHB shall meet at least once a month or as often as may be necessary.
- (b) A majority of the members of the board shall constitute a quorum, but the chair or the vice-chair must be present during meetings where budgetary proposals are being prepared or considered. The affirmative vote of all the majority of the members shall be necessary to approve such proposals.

Section 4. Compensation and Remuneration. - The chair, vice chair, and members of the municipal health board shall perform their duties as such without compensation or remuneration. Members thereof who are not government officials or employees shall be
