### ANTI-NOISY MUFFLER - TECHNICAL WORKING GROUP (ANM-TWG)

WHEREAS, the protection and promotion of the health, and the right to a peaceful environment is a primary concern of the Municipality of Baliwag;

WHEREAS, too much noise exposure may lead to hearing loss and serious health problems;

WHEREAS, for the Municipality to maintain the peace and order, there is a need to prohibit the use of modified mufflers in all private and public vehicles;

WHEREAS, for the Anti- Noisy Muffler rule to be implemented, the Municipality needs to designate a Technical Working Group to spearhead its implementation.

NOW, THEREFORE, I, FERDINAND V. ESTRELLA, Municipal Mayor, Municipality of Baliwag, Bulacan, by virtue of the powers vested in me by law, do hereby order:

**Section 2.** Powers and Functions. Anti- Noisy Muffler - Technical Working Group (ANM-TWG) shall:

- c. Prepare minutes of meetings and resolutions of the ANM-TWG.
- d. Prepare monitoring reports of the progress and needs of the implementation.
- e. Other tasks necessary and desirable in the full implementation of the program.

**Section 3.** Repealing Clause. All previous executive orders and issuances which are inconsistent herewith are hereby repealed or modified accordingly.

**Section 4.** Effectivity. This order shall take effect immediately.
