RECONSTITUTION OF THE BALIWAG TRICYCLE FRANCHISING AND REGULATORY BOARD (BTFRB)

WHEREAS, Section 4 of the *Kapasiyahan Bilang 43 Taong 2004* also known as Baliwag Tricycle Ordinance of 2004 defines the composition of the BTFRB with the Municipal Mayor as Chairperson, Municipal Treasurer, Chairperson for Peace and Order, Chairperson of Ways and Means, President of Tricycle Affairs, Representative from Integrated Bar of the Philippines, TODA Federation President, Chairperson of Barangay Grievance Committee and a representative from Non-Government Organization as members;

WHEREAS, there is a need to reconstitute the Baliwag Tricycle Franchising and Regulatory Board;

NOW, THEREFORE, I, FERDINAND V. ESTRELLA, Municipal Mayor of Baliwag, do hereby RECONSTITUTE the Baliwag Tricycle Franchising and Regulatory Board


SECTION 2. Powers and Functions. The BTFRB shall have the following functions:

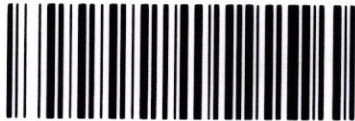
1. Conduct regular meetings;
2. Issue Motorized Tricycle Operator's Permit (MTO);
3. Assign Route/Zone/Terminal of the tricycle organizations and coding of tricycle sidecars;
4. Create such policies and measures that may deem necessary to carry out the objective of the Ordinance;
5. Study and approve fares of tricycle of all Tricycle Owners and Drivers' Association (TODA);
6. Formulate and impose sanctions to TODA officers and members who will violate the rules and regulations of their organization and the municipality;
7. Issue Traffic Violation Receipt to be used by Traffic Enforcers;
8. Assess financial statements of TODA and
9. Resolve issues and concerns of tricycle driver, operators and traffic enforcers.

SECTION 3. Repealing Clause. All previous Orders and issuances which are inconsistent herewith are hereby repealed or modified accordingly.

SECTION 4. Effectivity. This order shall take effect immediately.
