### EXECUTIVE ORDER No. 8

#### REORGANIZATION OF MUNICIPAL ANTI-DRUG ABUSE COUNCIL (MADAC)

WHEREAS, the Philippine Constitution mandates that the State shall promote the general welfare of the People;

WHEREAS, Section 16 of the Local Government Code of 1991 provides that the local government units shall ensure and support, among other things, improving public morals, maintaining peace and order, and preserving comfort and convenience of their inhabitants within their respective territorial jurisdictions.

WHEREAS, problems related to the use of prohibited drugs have continuously beset the Municipality of Baliwag, Bulacan, resulting to disturbance of peace and order and heinous crimes;

WHEREAS, there is a need to reorganize the MADAC due to the changes in the different offices comprising it.

NOW, THEREFORE, I, FERDINAND V. ESTRELLA, Municipal Mayor, Municipality of Baliwag, Bulacan, by virtue of the powers vested in me by law, do hereby order:

Section 1. There shall be reorganization in the Municipal Anti-Drug Abuse Council (MADAC) in so far as the composition of the said council is concerned. MADAC shall be composed of:

### **Section 2. Powers and Functions. The Municipal Anti-Drug Abuse Council (MADAC) shall:**

- a. Serve as a synergy point through which various organizations and individuals work together to plan, implement and evaluate programs on drug abuse prevention.
- b. Cause the efficient procurement of substantial funds, volunteers, facilities and technical expertise.
- c. Conduct meetings as often as necessary.
- d. Cause the effective planning, strategizing, implementing and evaluating programs and projects on drug abuse prevention in the Municipality.
- e. Continuously gather and update data on all drug related incidents and its effects on the peace and order situation in the Municipality.
- f. Submit a monthly report to the Provincial Anti-Drug Abuse Council.
- g. Order the investigation of suspected drug users as reported by Barangay Anti-drug Abuse Council (BADAC)
- h. Conduct an Information, Education Campaign on illegal drug reduction
- i. Monitor disposition and progress of drug-related filed cases
- j. Perform other related functions.


