CREATION OF A TECHNICAL WORKING GROUP FOR THE INFRASTRUCTURE AND ROAD NETWORK INVENTORY AND DEVELOPMENT

WHEREAS, the Basic Services and Facilities as stated under Section 17 of RA 7610 also known as the Local Government Code of 1991 mandates that the Local Government Unit shall exercise other powers and discharge other functions and responsibilities as are necessary, appropriate, or incidental to efficient and effective provision of the basic services and facilities such as:

- a. Municipal buildings, cultural centers, public parks including freedom parks, playgrounds, and sports facilities and equipment, and other similar facilities;
- b. Infrastructure facilities intended primarily to service the needs of the residents of the municipality and which are funded out of municipal funds including, but not limited to, municipal roads and bridges; school buildings and other facilities for public elementary and secondary schools; clinics, health centers and other health facilities necessary to carry out health services; communal irrigation, small water impounding projects and other similar projects; fish ports; artesian wells, spring development, rainwater collectors and water supply systems; seawalls, dikes, drainage and sewerage, and flood control; traffic signals and road signs; and similar facilities.

WHEREAS, there is a need to address road network and infrastructure concerns in the municipality;

NOW, THEREFORE, I, FERDINAND V. ESTRELLA, Municipal Mayor, Baliwag, Bulacan, by virtue of the powers vested in me by law, do hereby order:

Section 1. Composition. There shall be an Infrastructure and Road Network Inventory - Technical Working Group which shall be composed of:


Section 2. Duties and Functions. The Infrastructure and Road Network Inventory - Technical Working Group shall:

1. Cause the planning and development of a Road Network and Infrastructure Program.
2. Maintain an accurate inventory of road networks and infrastructures.
3. Ensure and oversee the optimum utilization of resources and improvement of a safe, efficient and environmentally balanced road network and infrastructures.
4. Spearhead the planning, managing and prioritizing of the maintenance of local roads and infrastructures.


Section 3. Repealing Clause. All orders issued and/or parts thereof contrary to or inconsistent with the provisions of this order are hereby repealed, modified or amended accordingly.

Section 4. Effectivity Clause. This order shall take effect immediately upon signing hereof and remains effective and binding unless revoked, repealed or modified.
