EXECUTIVE ORDER no. 41 s. 2016

CREATING A TECHNICAL WORKING GROUP (TWG) TO STUDY AND INCORPORATE IN THE CURRICULUM OF ELEMENTARY AND HIGH SCHOOLS' IMPORTANT LESSONS ABOUT THE HISTORY, ARTS AND CULTURAL HERITAGE OF BALIWAG

WHEREAS, Section 13 of the Philippine Constitution promulgates that the state shall inculcate in the youth patriotism and nationalism, and encourage their involvement in public and civic affairs;

WHEREAS, studying the history promotes patriotism and nationalism;

WHEREAS, Republic Act No. 10086 declares that the State shall likewise give utmost priority not only to the research on history but also to the popularization of history. In this way, the State will be able to build a Philippine national identity based on unity and pride in diversity held together by a common history.

WHEREAS, the preservation of inimitable heritage is in the public interest of the Baliwageños;

WHEREAS, to preserve the history of Baliwag, the municipality shall provide educational resources and guideline instructions, methodologies and alternative pedagogies for inclusion in the general curriculum of all students of both private and public schools of the Local Government Unit;

WHEREAS, for this Administrative Order to be implemented, the Municipality needs to designate a Technical Working Group to spearhead its implementation;

NOW, THEREFORE, I, FERDINAND V. ESTRELLA, Municipal Mayor, Municipality of Baliwag, Bulacan, by virtue of the powers vested in me by law, do hereby order:

SECTION 1. There shall be a Technical Working Group for this order and it shall be composed of:

- f. Prepare minutes of meetings and resolutions of the TWG.
- g. Prepare monitoring reports of the progress and needs of the implementation.
- h. Other tasks necessary and desirable in the full implementation of the program.
