Bidding will be conducted through open competitive bidding procedures using non-discretionary/ fail criterion as specified in the Implementing Rules and Regulation (IRR) of the Republic Act 9184, otherwise known as the Government Procurement Reform Act.

A complete set of Bidding Documents may be obtained/ purchase by interested bidders from the BAC Chairman upon payment of a non-refundable fee in the amount of One Thousand Pesos (Php 1,000.00).

It may also be downloaded free of charge from the website of the Philippine Government Electronics Procurement System (PhilGEPS) provided that bidders shall pay the fee for the Bidding Documents.

Bids must be accompanied by a bidder's bond, either in cash, manager's check or surety bond in the amount equivalent to Two Percent (2.0%) of the total amount of the Approved Budget for the Contract (ABC) and any Approved Equivalent.

The right is reserved for the Municipality of Baliwag to reject any or all bids, to waive any defects therein, and to accept such bids as may be considered most advantageous to the government.
