EXECUTIVE ORDER NO. 001 S. 2018

AMENDING THE EXECUTIVE ORDER NO. 20 S. 2016 ENTITLED AS “RECONSTITUTING THE PERFORMANCE MANAGEMENT TEAM (PMT) OF THE STRATEGIC PERFORMANCE MANAGEMENT SYSTEM (SPMS) AT THE MUNICIPAL GOVERNMENT OF BALIWAG” BY REORGANIZING ITS MEMBERS


The Human Resource Management Office shall serve as the secretariat of the Performance Management Team.
