EXECUTIVE ORDER NO. 19 S. 2018
IMPLEMENTATION OF THE REVISED REVENUE CODE OF BALIWAG

WHEREAS, Book II, Section 129 of the Local Government Code (LGC) of 1991 provides that each local government unit shall exercise its power to create its own sources of revenue and to levy taxes, fees, and charges subject to the provisions of the LGC, consistent with the basic policy of local autonomy;

WHEREAS, the income generated by the current Local Revenue Code is lesser compared to the current allocation required to the promotion of the general welfare of Baliwagenyos;

WHEREAS, the last adjustment for revision of the Revenue Code of Baliwag was in 1997 under Municipal Ordinance No. 03-1997 and Municipal Ordinance No. 10-2008 dated August 11, 2008 which is more than the prescribed five (5) years before any LGU could make a revision;

WHEREAS, the Municipality of Baliwag shall have to ensure that target collection revenue are met and expenditures are aligned with the prescribed allotment;

WHEREAS, the Local Government of Baliwag has formulated the Revised Revenue Code empowered by the Sangguniang Bayan (SB) Ordinance No. 16 S. 2018 entitled "An Ordinance Enacting the Revised Revenue Code of the Municipality of Baliwag, Province of Bulacan";

WHEREAS, by virtue of the Sangguniang Panlalawigan Resolution No. 169-S'18, the Revised Revenue Code of Baliwag was approved for application;

WHEREAS, this Order is created to execute the SB Ordinance No. 16 S. 2018 of the Municipality of Baliwag and the Sangguniang Panlalawigan of Bulacan Resolution No. 169-18 which ratifies the implementation of the Revised Revenue Code of Baliwag;




