INSTITUTIONALIZATION OF THE HATID KALINGA PROGRAM FOR THE SENIOR
CITIZENS

WHEREAS, Pursuant to Article XV, Section 4 of the Constitution, it is the duty of the family to take care of its elderly members while the State may design programs of social security for them;

WHEREAS, Pursuant to Article XIII, Section 11 of the Constitution provides that the State shall adopt an integrated and comprehensive approach to health development which shall endeavor to make essential goods, health and other social services available to all the people at affordable cost. There shall be priority for the needs of the underprivileged, sick, elderly, disabled, women and children;

WHEREAS, it is the duty of the municipality to reach out to the Senior Citizens in the barangays and to encourage them to actively participate and be involved in its programs;

WHEREAS, one of the objectives of RA No. 9994 is to recognize the rights of senior citizens to take their proper place in society and make it a concern of the family, community, and government;

WHEREAS, the institutionalization of the Hatid Kalinga Program will lead to its sustainability and continuity of the program;

NOW THEREFORE, by the powers vested in me by law, I, **FERDINAND V. ESTRELLA**, Municipal Mayor of Baliwag, hereby order the institutionalization of the Hatid Kalinga Program of the Municipal Government of Baliwag.

SECTION 1. CONCERNED OFFICES. The offices in charge for the implementation of Hatid Kalinga Program are primarily Municipal Health Office and the Community Affairs Office.

SECTION 2. DUTIES AND RESPONSIBILITIES. The concerned offices are in charge of the following:

2.1 Municipal Health Office

- 2.1.1 Prepare program of plan or budget proposal
- 2.1.2 Identification, Profiling and Validation of beneficiaries as to their medical needs
- 2.1.3 Conduct monthly checkups of beneficiaries or as needed
- 2.1.4 Update medication of beneficiaries including their dose and schedule of intake
- 2.1.5 Prepare and pack the maintenance medication properly and correctly for the intended recipient
- 2.1.6 Conduct evaluation and monitoring of the program for the COA quarterly and as needed

2.2 Community Affairs Office

- 2.2.1 Prepare program of plan or budget proposal
- 2.2.2 Ensure proper, accurate, and timely delivery of medication to the intended beneficiary
- 2.2.3 Ensure proper packaging and storage of medication during delivery
- 2.2.4 Identify, profile, and validate beneficiaries as to their needs other than medical
- 2.2.5 Conduct monitoring and evaluation of the program.

SECTION 2. BENEFICIARIES. The beneficiaries are the senior citizens living in Baliwag identified and profiled by Municipal Health Office and Community Affairs Office.


SECTION 4. EFFECTIVITY CLAUSE. This Executive Order shall take effect immediately.
