**CREATION OF THE BALIWAG PUBLIC-PRIVATE PARTNERSHIP BOARD TECHNICAL
WORKING GROUP OF THE MUNICIPALITY OF BALIWAG**

WHEREAS, The 1987 Constitution recognizes the indispensable role of the private sector in development, encourages private enterprise, and provides incentives to needed investments.

WHEREAS, Under Section 25 (b) of the 1991 LGC, the Municipality may collaborate or cooperate with other local governments, national government agencies, government-owned and controlled corporations, government instrumentalities and government corporate entities for the implementation of the local projects;

WHEREAS, the Executive Order No. 9 series of 2017 orders the establishment of the Baliwag Public-Private Partnership Board which is expedient to establish a Baliwag PPP Board Technical Working Group to help the PPP Board to execute public-private Partnerships in the Municipality of Baliwag so as to promote domestic and foreign private investment, set up transparent and efficient institutional arrangements for PPP and promote private sector participation in the economic development amongst others;

WHEREAS, based on the above premises, BPPPB requires a Technical Working Group to study and initiate the publication of the Baliwag Public-Private Board in the Municipality of Baliwag.

NOW, THEREFORE, I, FERDINAND V. ESTRELLA, Municipal Mayor, Municipality of Baliwag, Bulacan, by the virtue of the powers vested in me by law, do hereby order the following:

SECTION 1. COMPOSITION OF THE BOARD. The Baliwag Public-Private Partnership Board Technical Working Group is hereby created and shall compose of the following members:

5. Others as maybe identified


SECTION 3. REPEALING CLAUSE. All orders, issuances and memorandum issued inconsistent herewith are hereby repealed and/ or modified accordingly.
