EXECUTIVE ORDER NO. 003S. 2019

**AN ORDER CREATING THE EVALUATION TEAM FOR THE BARANGAY SEAL OF
GOOD LOCAL GOVERNANCE IN THE MUNICIPALITY OF BALIWAG**

WHEREAS, Section 3 (h) and (m) and Section 16 of the Republic Act No. 7160, otherwise known as the Local Government Code of 1991, provide that there shall be a continuing mechanism to enhance local autonomy not only by legislative enabling acts but also by administrative and organizational reforms, that the national government shall ensure that decentralization contributes to the continuing improvement of the performance of local government units and the quality of community life, that each LGU shall exercise its powers essential to the promotion of the general welfare and provision of basic services and facilities;

WHEREAS, it is the goal of this administration to continue its pattern of rapid growth into the foreseeable future;

WHEREAS, Section 3 (j) of the Local Government Code of 1991 states that there should be an effective mechanisms for ensuring the accountability of local government units to their respective constituents shall be strengthened in order to upgrade continually the quality of local leadership;

WHEREAS, based on the above premises, the Municipality of Baliwag requires a Seal of Good Local Governance evaluation team for barangay to perform functions such as evaluating and auditing the documents required in passing and exceeding the principle and essential areas set in the program. Moreover, with the guidance of these evaluation team it will uplift and upgrade the standards of different barangays for the program;

NOW, THEREFORE, I, FERDINAND V. ESTRELLA, Municipal Mayor, Municipality of Baliwag, Bulacan, by the virtue of the powers vested in me by law, do hereby order the creation of the Seal of Good Local Governance for Barangay.

SECTION 4. SEPARABILITY CLAUSE. If any section or part of this Executive Order is held unconstitutional or invalid, the other sections or provisions not otherwise affected shall remain in full force or effect.
