EXECUTIVE ORDER NO. 08-17S. 2016

AN ORDER ENFORCING THE FINES OF "NO SEGREGATION, NO COLLECTION POLICY"
OF KAUTUSANG BAYAN NO. 11. S.2005 ALSO KNOWN AS THE ECOLOGICAL SOLID
WASTE MANAGEMENT ORDINANCE OF BALIWAG

WHEREAS, pursuant to the provisions of Republic Act No. 9003, otherwise known as the "Philippine Ecological Solid Waste Management Act of 2000, it is the policy of the State to adopt a systematic, comprehensive and ecological solid waste management program which shall ensure the proper segregation, collection, transport, storage, treatment and disposal of solid waste through the formulation and adoption of the best environmental practices in ecological waste management excluding incineration;

WHEREAS, Kautusang Bayan No. 11 Sec. 20 or the "No Segregation, No Collection Policy" of Baliwag prohibits the collection of non-segregated garbage in the municipality;

WHEREAS, in order to instill discipline to its citizens, and the nearby communities that disposes their garbage in the municipality's area of jurisdiction, the municipality shall spearhead the implementation of fines provided in Kautusang Bayan No. 11 of Baliwag;

NOW THEREFORE, I, FERDINAND V. ESTRELLA, Municipal Mayor of the Municipality of Baliwag, Bulacan, by virtue of the powers vested in me by law, do hereby order:

SECTION 1. TITLE.

This law shall be known as An Order Enforcing Fines Of "No Segregation, No Collection Policy" Of Kautusang Bayan No. 11. S.2005.

SECTION 2. PROHIBITED ACT AND CORRESPONDING PENALTIES.

The following is the prohibited act and its corresponding penalties as provided by Section 20 of Kautusang Bayan No. 11 of Baliwag:

2.1 Prohibited Act – Open dumping of garbage and non-segregation of wastes.

2.2 Penalties – Violation of this Executive Order shall be penalized as follows:

a. First Offense	-	PHP 500.00
b. Second Offense	-	PHP 1,000.00
c. Third Offense	-	PHP 1,500.00

Provided that any subsequent and repeated violation shall subject the offender to the maximum penalty of fine not more than PHP 2,500.00 or an imprisonment of not less than one (1) day but not more than fifteen (15) days or both, such fine and imprisonment at the discretion of the court.

SECTION 3. ENFORCEMENT

The Municipal Environment and Natural Resources Office (MENRO) and the Barangay Officials shall enforce compliance with this Executive Order. The MENRO may deputize the ECO-POLICE for enforcement purpose. With this the MENRO, Barangay Officials and ECO-POLICE shall have the power to:

- a. Conduct regular inspection to all collection routes, most specially to the central business areas located at main road and other major thoroughfares;
- b. Issue a citation ticket to every individual who will violate this order.
- b. Consolidate all the 4th offenders and create a short list to be forwarded to the Municipal Mayor's Office. The Municipal Legal Officer shall be responsible in filing the necessary complaint before proper court against apprehended violators of this Executive Order associated to Kautusang Bayan No. 11 who failed to pay their penalties.

SECTION 4. PAYMENT OF PENALTY.

The violators shall pay the penalty at the Barangay Hall or the Municipal Treasury Office within seventy-two (72) hours after the violation time stated at the citation ticket. The receipt payment shall be presented to the office who issued the citation ticket for clearance and proper documentation. The Barangay Treasurer shall submit the collected payments to the Municipal Treasury office for appropriate accounting.

SECTION 5. SEPARABILITY CLAUSE

If any section or part of this Order is held unconstitutional or invalid, the other sections or provisions not otherwise affected shall remain in full force and effect.


SECTION 6. REPEALING CLAUSE

SECTION 7. EFFECTIVITY CLAUSE

This effect shall take effect thirty (30) days after posting of this Order on conspicuous places.
