EXECUTIVE ORDER NO. 035, s. 2019

PROJECT MONITORING COMMITTEE OF BALIWAG

WHEREAS, Executive Order No. 93 s. 1993, mandates the Regional Project Monitoring Committee (RPMC) to oversee all foreign assisted projects (loan or grant funded), interprovincial projects, area development projects, nationally-funded and locally-funded projects, and other projects considered critical by the Office of the President and the Regional Development Council, which are implemented in the region;

WHEREAS, the Department of Interior and Local Government (DILG) has issued Memorandum Circular No. 2004-78 dated June 22, 2004, enjoins the local government units to organize, reactivate or reconstitute the local Project Monitoring Committee (PMCs) in their respective areas of jurisdiction;

WHEREAS, the local Project Monitoring Committee is necessary for the monitoring, evaluation and formulation of recommendations on the implementation of development plans and programs in the municipality;

NOW, THEREFORE, I FERDINAND V. ESTRELLA, Municipal Mayor, Municipality of Baliwag, Bulacan, by virtue of the powers vested in me by law, do hereby order the following:

SECTION 1. CREATION. There shall be a Project Monitoring Committee in the Municipality of Baliwag.

SECTION 2. COMPOSITION. The Project Monitoring Committee shall be composed of the following:

SECTION 3. FUNCTIONS. The Local Project Monitoring Committee shall:

1. Adopt system of integration, coordination and linkage of all monitoring activities of the Municipality;
2. Collect and process reports of implementers and monitoring on the status of program/ project implementation;
3. Identify problems/ issues that may impede project implementation and recommend remedial actions;
4. Provide feedback on the remedial actions undertaken to the Municipal Mayor or the Municipal Development Council;
5. Prepare disseminate periodic (month or quarterly) project monitoring reports on the status of project implementation;




6. Assess and ascertain whether projects implemented are supportive to the development of the Municipality.

SECTION 4. REPEALING CLAUSE. All orders issued and/or parts thereof contrary to or inconsistent with the provisions of this order are hereby repealed, modified or amended accordingly.

SECTION 5. SEPARABILITY CLAUSE. If any section or part of this Executive Order is held unconstitutional or invalid, the other sections or provisions not otherwise affected shall remain in full force or effect.

SECTION 6. EFFECTIVITY CLAUSE. This order shall take effect immediately upon signing hereof and remains effective and binding unless revoked, repealed or modified.
