EXECUTIVE ORDER NO. *28* S. 2019

**REORGANIZATION OF THE MUNICIPAL HEALTH BOARD OF THE MUNICIPALITY OF
BALIWAG, BULACAN**

WHEREAS, Section 102 of Republic Act 7160, mandates that there shall be established in the municipality, a Municipal Health Board;

WHEREAS, Section 16 of the same RA provides that the local government units shall promote and ensure the health and safety of its inhabitants;

NOW, THEREFORE, I, FERDINAND V. ESTRELLA, Municipal Mayor, Municipality of Baliwag, Bulacan, by virtue of the powers vested in me by law, do hereby order:

SECTION 1. There shall be a Municipal Health Board (MHB) at the Municipality of Baliwag, Bulacan which shall be composed of:

Municipal Health Office

MEMBERS: HON. LOWELL C. TAGLE

Chair, Committee on Health, Sangguniang Bayan

SECTION 2. Functions of the Municipal Health Board. The Municipal Health Board shall:

(1) To propose to the *Sangguniang Bayan*, in accordance with standards and criteria set by the Department of Health, annual budgetary allocations for the operation and maintenance of health facilities and services within the municipality.

(2) To serve as an advisory committee to the *Sangguniang Bayan* on health matters such as, but not limited to, the necessity for, and application of, local appropriations for public health purposes; and

(3) Consistent with the technical and administrative standards of the Department of Health, create committees which shall advise local agencies on matters such as, but not limited to, personnel selection and promotion, bids and awards, grievances and complaints, personnel discipline, budget review, operations review and similar functions.

SECTION 3. Meetings and Quorum;

- a. The MHB shall meet at least once a month or as often as may be necessary.
- b. A majority of the members of the board shall constitute a quorum, but the chair or the vice-chair must be present during meetings where budgetary proposals are being prepared or considered. The affirmative vote of all the majority of the members shall be necessary to approve such proposals.

SECTION 4. Compensation and Remuneration. The chair, vice chair, and members of the municipal health board shall perform their duties as such without compensation or remuneration. Members thereof who are not government officials or employees shall be entitled to necessary traveling expenses and allowances chargeable against the funds of the MHB, subject to existing accounting and auditing rules and regulations.


SECTION 5. Direct National Supervision and Control by the Secretary of Health. - In cases of epidemics, pestilence, and other widespread public health dangers, the Secretary of Health may, upon the direction of the President and in consultation with the Municipality of Baliwag, Bulacan, temporarily assume direct supervision and control over health operations for the duration of the emergency, but in no case exceeding a cumulative period of six (6) months. With the concurrence of the local government unit, the period for such direct national control and supervision may be further extended.

SECTION 6. REPEALING CLAUSE. All orders, issuances and memorandum issued inconsistent herewith are hereby repealed and/ or modified accordingly.

SECTION 7. SEPARABILITY CLAUSE. If any section or part of this Executive Order is held unconstitutional or invalid, the other sections or provisions not otherwise affected shall remain in full force or effect.


SECTION 8. EFFECTIVITY. This Executive Order shall take effect immediately.
