EXECUTIVE ORDER NO. 050 S. 2019
RECONSTITUTING THE LOCAL HOUSING BOARD OF THE MUNICIPALITY OF
BALIWAG

WHEREAS, Article XII, Section 9 of the 1987 Constitution provides that “The State shall, by law, and for common good, undertake, in cooperation with the private sector, continuing program land reform and decent housing model, make available at affordable cost decent housing and basic services for the underprivileged and homeless citizens in resettlement area”;

WHEREAS, the Local Government Code of 1991 likewise mandates local government unit with the responsibility to provide basic services and facilities to include programs and projects for low cost housing and mass dwellings;

WHEREAS, Republic Act 7279 or the “Urban Development and Housing Act ` also provides for the preparation of a comprehensive and continuing housing program, establish the mechanism for each implementation and for other purposes;

WHEREAS, the growing population of Baliwag is expected to generate pressure on land resources which necessitates a rationalized and planned approach in the construction of dwelling units;

WHEREAS, the Local Government of Baliwag recognizes the need for a long term housing plan as an integral part of the socio-economic development of the Municipality;

NOW, THEREFORE, I, FERDINAND V. ESTRELLA, Municipal Mayor of the Municipality of Baliwag, Bulacan, by virtue of the powers vested in me by law, do hereby order the reconstitution of the Local Housing Board of the Municipality of Baliwag:

SECTION 1. COMPOSITION. The Local Housing Board shall be composed of the following:

Chairman: Municipal Mayor
Members: Municipal Administrator
Local Resettlement and Sheltering Unit
Municipal Social Welfare and Development
Municipal Planning and Development Office
Municipal Engineering Office
One (1) Representative from Civil Society Organization

SECTION 2. FUNCTIONS OF THE BOARD.


1. Formulate the short, medium and long term shelter development plan of the Municipality in accordance and based on the development priorities of the Baliwag Comprehensive Plan.
2. Establish policies and implementing guidelines for the Municipality's housing program in consonance with Republic Act no. 7279.
3. Formulate policies guidelines on the overall rural development (i.e. basic services and facilities, social enterprises, security of land tenure, infrastructure, health, water and sanitation, solid waste disposal, disaster management directed to mitigation and adaptation vis-à-vis climate change, education and others.
4. Monitor the implementation of the housing policies and programs of the Municipality.
5. Obtain establish and manage resources for the Municipality's housing program.
6. Link and network with government agencies, bilateral organizations, non-governmental organizations and the private sectors involved in socialized housing programs and integrated social housing delivery under the framework of convergence of resources.

SECTION 3. REPEALING CLAUSE. All orders, issuances, and memorandum issued inconsistent herewith are hereby repealed or modified accordingly.

SECTION 4. SEPARABILITY CLAUSE. If for any reason any portion or provision of this Executive Order is declared unconstitutional or invalid, the other sections or provisions thereof which are not affected shall continue in force and effect.


SECTION 5. EFFECTIVITY CLAUSE. This Executive Order shall take effect immediately.
