EXECUTIVE ORDER NO. 002 S. 2020

RECONSTITUTING THE MEMBERS OF THE BIDS AND AWARDS COMMITTEE (BAC)

WHEREAS, Article V, Section 11 of the Republic Act 9184 otherwise known as the *Government Procurement Reform Act* mandates the establishment of Bids and Awards Committee of every procuring entity to facilitate professionalization and harmonization of procurement procedures and standards;

WHEREAS, the Bids and Awards Committee of the Municipality of Baliwag was established by virtue of Executive Order No. 05 S. 2016 ;

WHEREAS, Republic Act 9184 provides that the members of the BAC shall have a fixed term of one (1) year reckoned from the date of appointment, renewable at the discretion of the Head of the Procuring Entity;

WHEREAS, there is a need to reconstitute the members of the Municipal Bids and Awards Committee in accordance with the Government Procurement Reform Act;

NOW THEREFORE, I, FERDINAND V. ESTRELLA, by virtue of the power vested upon me by the law, do hereby order the reconstitution of the Bids and Awards Committee with the following provisions:

SECTION 1. COMPOSITION

SECTION 2. FUNCTIONS- Sections 12 and 14 of the Implementing Rules and Regulations of the Republic Act 9184 is being adopted and deemed incorporated hereof.


SECTION 3. OBSERVERS- To enhance the transparency of the process, the BAC shall, during the eligibility checking, shortlisting, pre-bid conference, preliminary examination of bids, bid evaluation, and post-qualification, invite, in addition to the representative of the COA, at least two (2) observers, who shall not have the right to vote, to sit in its proceedings.

SECTION 4. REPEALING CLAUSE. All orders, issuances and memorandum issued inconsistent herewith are hereby repealed and or modified accordingly.

SECTION 5. SEPARABILITY CLAUSE. If for any reason or reasons, any part or provision of this Act shall be declared unconstitutional or invalid, other parts or provisions not affected thereby shall continue to be in full force and effect.

SECTION 6. EFFECTIVITY CLAUSE. This Executive Order shall take effect immediately.
