**CREATING THE MUNICIPAL GOVERNMENT OF BALIWAG REVIEW AND COMPLIANCE  
 COMMITTEE FOR THE REVIEW OF SALN**

**WHEREAS**, The Constitution of the Republic of the Philippines requires public officers and employees to submit upon assumption of office and during such period as may be required by law, a declaration under oath of their assets, liabilities and net worth (SALN).

**WHEREAS**, Section 8 of the Republic Act 6713 or the "Code of Conduct and Ethical Standards for Public Officials and Employees states that public officials and employees have an obligation to accomplish and submit declarations under oath of, and the public has the right to know, their assets, liabilities, net worth and financial and business interests including those of their spouses and of unmarried children under eighteen (18) years of age living in their households;

**WHEREAS**, CSC Resolution Number 1300455 dated March 4, 2013 resolved to adopt the guidelines in the review and compliance procedure in the filing and submission of the SALN;

**WHEREAS**, for purposes of the submission of the SALN Form, Review and Compliance Committee is created to ensure that proper filing and timely submission of the Statement of Assets, Liabilities an Net Worth (SALN) and Disclosure of Business Interests and Financial Connections, is observed by the agency;

**THEREFORE, I, FERDINAND V. ESTRELLA**, Municipal Mayor of Baliwag, Bulacan, by virtue of the powers vested in me by law do hereby order the **CREATION OF THE MUNICIPAL GOVERNMENT OF BALIWAG REVIEW AND COMPLIANCE COMMITTEE FOR THE REVIEW OF SALN** which shall abide by the following provisions:

**SECTION 1. COMPOSITION.** The Municipal Government of Baliwag Review and Compliance Committee for the Review of SALN shall be composed of the following:


**SECTION 2: DUTIES.** The Review and Compliance Committee shall prepare a list of the following employees, in alphabetical order to be submitted to the head of agency copy furnished the Civil Service Commission on or before May 15 of every year:

- a. Those who filed their SALNs with complete data;
- b. Those who filed their SALNs but with incomplete data, and
- c. Those who did not file their SALNs.

**SECTION 3. REPEALING CLAUSE.** All executive orders, rules and regulations that are inconsistent herewith shall be deemed revoked, amended and/or repealed accordingly.

**SECTION 4. EFFECTIVITY.** This Executive Order shall take effect immediately.
