EXECUTIVE ORDER NO. 013 S.2020

AN ORDER CONSTITUTING THE GALING POOK AWARDS STEERING COMMITTEE OF
THE MUNICIPALITY OF BALIWAG

WHEREAS, Section 3 (h) and (m) and Section 16 of the Republic Act No. 7160, otherwise known as the Local Government Code of 1991, provides that there shall be a continuing mechanism to enhance local autonomy not only by legislative enabling acts but also by administrative and organizational reforms, that the national government shall ensure that decentralization contributes to the continuing improvement of the performance of local government units and the quality of community life, that each local government unit shall exercise its powers essential to the promotion of the general welfare and provision of basic services and facilities;

WHEREAS, Section 3 (j) of the Local Government Code states that there should be an effective mechanisms for ensuring the accountability of the local government units to their respective constituents shall be strengthened in order to upgrade continually the quality of local leadership;

WHEREAS, it is the goal of this administration to continue its pattern of rapid growth into the foreseeable future;

WHEREAS, based on the above premises, there is a need to create a steering committee for the Galing Pook Awards to perform functions such as evaluating the documents required in passing and exceeding the principle and essential areas set in the program;

NOW THEREFORE, I, FERDINAND V. ESTRELLA, Municipal Mayor of the Municipality of Baliwag, by the virtue of the powers vested in me by law, do hereby order the creation of Galing Pook Awards Steering Committee.

SECTION 2. DUTIES AND RESPONSIBILITIES.

1. Check all requirements needed for the Galing Pook Awards.
2. Evaluate the document required for the assessment validation.
3. Oversee implementation of programs and compliance of the Municipality to the Galing Pook Awards.
4. Others as may be identified.

SECTION 3. MEETINGS OF THE COMMITTEE. The Committee shall meet regularly at least once every quarter, without prejudice to special meetings to be called by the Chairperson as may be necessary. The Committee shall promulgate guidelines for the conduct of its official business.

SECTION 4. THE COMMITTEE SECRETARIAT. The Municipal Administrator's Office, shall jointly function as the Committee Secretariat, which shall provide technical and administrative support to the Committee.


