EXECUTIVE ORDER NO. 008S.2019

**CREATION OF A TECHNICAL WORKING GROUP TO FORMULATE AND DEVELOP THE
 COMMUNITY SUPPORT, AFTERCARE ANG REINTEGRATION (CSAR) PLAN OF THE
 MUNICIPALITY OF BALIWAG**

WHEREAS, the Joint Memorandum Circular no. 2018-01 of Department of Interior of Local Government and Dangerous Drugs Board sets the minimum standard functionality and effectiveness of local anti-drug abuse council that covers all local government units including the formulation of a Community Support Aftercare and Reintegration Plan;

WHEREAS, on the latest 2017 Anti-Drug Abuse Council Performance Audit the Municipality of Baliwag got the rating of Moderate High Functionality;

WHEREAS, there is a need to formulate a Community Support Aftercare and Reintegration Plan to serve as an aftercare to the graduates of Bahay Pagbabago Reformation Center;

NOW THEREFORE, by the powers vested in me by law, I **FERDINAND V. ESTRELLA**, Municipal Mayor of Baliwag, hereby order the creation of the Technical Working Group to formulate and develop the Community Support Aftercare and Reintegration (CSAR) Plan of the Municipality of Baliwag;

SECTION 2. DUTIES AND RESPONSIBILITIES:


1. Conduct regular meetings in pursuit of the objectives of the creation of this Technical Working Group;

SECTION 3. REPEALING CLAUSE. All orders, issuances and memorandum issued inconsistent herewith are hereby repealed and/or modified accordingly.

SECTION 4. SEPARABILITY CLAUSE. If any section or part of this Executive Order is held unconstitutional or invalid, the other sections or provisions not otherwise affected shall remain in full force or effect.


SECTION 5. This Executive Order shall take effect immediately.
